#### b) The prevention of crime and disorder

CCTV equipment with a sufficient number of cameras located in key areas will be installed and maintained at the premises which will be able to record colour imagery that will allow the police to be able investigate any potential crimes made on the premises. There will be 2 cameras located by the main door which will obtain images of any customer leaving or entering the building. All CCTV footage will be stored on a drive for at least 28 days.

All staff will be fully trained in crime & disorder, drugs, knife crime and operate a Think Challenge 25 policy.

We will operate a refusal log of all customers refused alcohol or have been asked to leave in the past because of any crime or disorder. This log will be shared with the police whenever needed. The log will contain the following information and be backed up my the CCTV.

#### c) Public safety

All notices in relation to public health & safety will be prominently displayed at the premises.

The management will also ensure that the premises will be operated in line with Health & safety Act and any environmental health issues will be the responsibility of the premises license holder.

The management will be responsible for conducting Fire Risk assessment and also a Health & Safety Risk Assessment for the licensed premises

Adjustments will be made for disabled access.

#### d) The prevention of public nuisance

We will have signs and poster in place by the door.

All of our staff (including door staff) will be trained to remind ALL customers to leave quietly and respect the neighbours/locals.

We will supervise all customers when leaving after 23.00.

We will ensure that ALL customers have a glass of free potable water before leaving the premises.

On busier nights we will ensure that ALL customers have a homemade foraged lollipop. We will also give them a copy of our monthly newsletter or a copy of Good On Paper so they can read all the way home.

#### e) The protection of children from harm

The bar will have full CCTV both inside and out.

We will have signage around the bar

All of our staff will have regular training on when and how to refuse a sale.

We will always operate a Think Challenge 25 policy

We will ensure that all children are out of the premises no later that 19.45.

Our premises is not solely about alcohol but a 50/50 mix between non and alcohol. The bars ethos is all about locality, seasonality and community so we will always offer free potable water and have an extensive non alcoholic range of drinks, with the majority being sugar free, We will always use alternative sugars as we are very aware about the dangers off sugar with children.

ALL children must be accompanied by a responsible adult.

## The Highways Act 1980, Section 26 Public Path Creation Order Additional Footpath between Folly Lane to Beeches Green, Stroud

Gloucestershire County Council has received a Definitive Map Modification Order application to add a section of path to the legal record of Public Rights of Way, the Definitive Map and Statement. This well-used route is not included on the Definitive Map of Public Rights of Way and there is a public need to add this section to the legal record. We therefore intend to add the path under Section 26 of the Highways Act 1980.

The length of path is shown on the attached map; the proposed footpath is shown between A-B, with a width varying from 1 to 2.5 metres along the route.

We are contacting Stroud Town Council as part of the consultation process before the Public Path Creation Order is published. This is not a public consultation. We have informed landowners and occupiers adjacent to the route about the proposal.



## GAPTC response to NALC survey on MHCLG proposed reforms to the NPPF and other planning reforms

Questions 1-3 are details of the organisation.

- 4. Do you agree that the government should reverse the December 2023 changes made to paragraph 61?
  Yes.
- 5. Please explain your answer to the previous question.

The rigid national housing targets introduced in December 2023 overlook local conditions, particularly in areas with significant environmental protections like the Cotswolds AONB (National Landscape). Local assessments should drive housing needs rather than fixed quotas that disregard regional factors such as infrastructure capacity and environmental constraints. The December 2023 changes impose housing targets that do not adequately consider the unique challenges of rural areas, particularly those with sensitive landscapes. Local authorities must retain flexibility in setting targets that reflect local needs and constraints. In Gloucestershire, the character and infrastructure capacity of areas like the Forest of Dean and Stroud District must be preserved while balancing housing delivery.

- 6. Do you agree that the government should remove reference to the use of alternative approaches to assessing housing need in paragraph 61 and the glossary of the NPPF?
  No.
- 7. Please explain your answer to the previous question.

Local conditions and constraints vary significantly, and alternative approaches are essential to ensure that housing assessments reflect the specific challenges of each area. Uniform methodologies fail to account for factors like AONBs (National Landscapes), conservation areas, and local infrastructure, which are critical considerations in regions like Gloucestershire. A single, standardized approach cannot accommodate the diverse needs and characteristics of different regions. In areas like the Cotswolds, where development potential is severely limited by environmental protections, alternative approaches allow for more accurate assessments that reflect local realities. This flexibility is essential for balancing growth with environmental sustainability.

8. Do you agree the government should reverse the December 2023 changes made on the urban uplift by deleting paragraph 62? Yes.

9. Please explain your answer to the previous question.

The urban uplift policy places unrealistic pressure on large urban conurbations like Gloucester and Cheltenham by imposing high growth targets without considering the capacity of existing infrastructure. This could lead to urban sprawl and overdevelopment, which would undermine local plans and exacerbate infrastructure challenges. Urban uplift targets could force growth into areas that are not equipped to handle additional population and development. For instance, in Cheltenham, higher housing targets could strain transport networks, healthcare, and schools, leading to unsustainable urban expansion. Local authorities should have the discretion to set growth targets based on realistic infrastructure capacity and community needs.

- 10. Do you agree the government should reverse the December 2023 changes made on character and density and delete paragraph 130? Yes.
- 11. Please explain your answer to the previous question.

The changes diminish local authorities' ability to enforce design codes that preserve the distinct character of communities, particularly in heritage and conservation areas. Protecting local identity is vital for areas like the Cotswolds and the Forest of Dean, where community character is closely tied to economic activities like tourism. Local character and identity are key considerations in planning, particularly in regions where heritage and landscape play a significant role in the local economy and community well-being. Reversing the changes would empower councils to apply design codes that maintain the visual and cultural identity of their communities, ensuring that new developments are sympathetic to the existing environment.

- 12. Do you agree that the focus of design codes should move towards supporting spatial visions in local plans and areas that provide the greatest opportunities for change such as greater density, in particular the development of large new communities?

  Yes.
- 13. Please explain your answer to the previous question.

The focus must remain sensitive to local contexts. High-density development may be appropriate in some areas, but it should not be imposed universally. Design codes should prioritize local character and community identity while allowing for appropriate growth, particularly in rural and heritage areas. Design codes should align with local spatial visions while reflecting the specific needs and characteristics of each community. In Gloucestershire, areas like Tewkesbury Borough prioritize heritage preservation and environmental sustainability. Design codes must be flexible enough to support growth in a way that respects local identities, balancing new developments with the preservation of existing community character.

14. Do you agree that the presumption in favour of sustainable development should be amended as proposed?

Yes.

#### 15. Please explain your answer to the previous question.

The amendments better align sustainability goals with local planning needs by integrating infrastructure, environmental, and social considerations. Sustainable development should focus on creating cohesive communities with the necessary infrastructure and services in place, while protecting the environment and local heritage. Sustainability involves more than just meeting housing quotas. It requires balanced growth that considers long-term environmental impacts, infrastructure capacity, and community well-being. In Gloucestershire, developments must be carefully integrated with existing communities to avoid straining resources and degrading the environment. The proposed amendments emphasize a more holistic approach to sustainability, which is critical for regions like Stroud and the Forest of Dean.

16. Do you agree that all local planning authorities should be required to continually demonstrate 5 years of specific, deliverable sites for decision-making purposes, regardless of plan status?

No.

#### 17. Please explain your answer to the previous question.

Requiring a continuous 5-year land supply risks encouraging speculative development and planning by appeal, which could undermine local plans and lead to developments that do not align with infrastructure capacity or community needs. Councils need flexibility to manage land supply based on local circumstances and strategic planning objectives. The continuous 5-year supply requirement often results in rushed approvals and speculative developments, particularly in areas where land is scarce or where environmental protections are in place. In regions like the Cotswolds, strict adherence to this requirement could lead to inappropriate developments that damage the landscape and disrupt community cohesion. Local planning authorities should have the discretion to manage land supply in a way that balances growth with environmental and social considerations.

18. Do you agree with the government proposal to remove wording on national planning guidance in paragraph 77 of the current NPPF?

#### 19. Please explain your answer to the previous question.

National guidance provides essential baseline standards that ensure consistency and quality across the country. While local flexibility is important, clear national standards are necessary to maintain high-quality developments and to protect important national objectives like environmental sustainability and heritage conservation. Removing national guidance risks creating inconsistencies in planning outcomes and could lead to developments that fall below acceptable standards. In areas like Gloucestershire, where planning challenges include balancing growth with conservation, national guidelines provide a critical framework that helps local authorities navigate complex issues while ensuring that developments contribute positively to the community and environment.

- 20. Do you agree that all local planning authorities should be required to add a 5% buffer to their 5-year housing land supply calculations?
- 21. Do you agree that Planning Practice Guidance should be amended to specify that the appropriate baseline for the standard method is housing stock rather than the latest household projections?

  Yes.
- 22. Please explain your answer to the previous question.

Housing stock is a more stable and realistic measure for planning purposes, providing a consistent baseline that reflects the actual capacity of local areas. Household projections can be volatile and may not accurately represent long-term trends or local conditions, particularly in areas with fluctuating demographics or significant environmental constraints. Using housing stock as a baseline ensures that growth is aligned with the real capacity of communities to accommodate development, reducing the risk of overdevelopment. In Gloucestershire, where environmental and infrastructure limitations are significant, housing stock offers a more reliable foundation for planning than speculative household projections.

23. Do you agree that using the workplace-based median house price to median earnings ratio, averaged over the most recent 3-year period for which data is available to adjust the standard method's baseline, is appropriate?

Yes.

24. Please explain your answer to the previous question.

Affordability metrics that consider both housing costs and local earnings provide a more accurate picture of housing need, ensuring that developments, particularly those involving affordable homes, are targeted towards areas where they are most needed. This approach is particularly relevant in areas like Cheltenham, where high house prices are a barrier to local workers accessing housing. Linking housing delivery to affordability metrics ensures that growth is responsive to local economic conditions and helps address imbalances in the housing market. By considering workplace-based earnings, the standard method can better align housing delivery with local needs, especially in regions where affordability is a significant challenge.

- 25. Do you agree that affordability is given an appropriate weighting within the proposed standard method?
  Yes.
- 26. Do you agree the government should make the proposed change set out in paragraph 124c, as a first step towards brownfield passports? Yes.
- 27. Please explain your answer to the previous question.

  Prioritizing brownfield development aligns with sustainable land use principles and helps protect greenfield sites. The introduction of brownfield passports

could streamline the development process for previously developed land, encouraging regeneration and reducing pressure on more sensitive areas like the Green Belt and AONBs (National Landscapes). The introduction of brownfield passports could facilitate the reuse of previously developed land, aligning with sustainable development objectives and reducing pressure on greenfield sites. By streamlining the process for bringing brownfield sites into use, this change supports regeneration in urban areas and helps preserve the character and environmental value of rural areas like those found across Gloucestershire. Brownfield passports provide a mechanism to fast-track developments that meet clear criteria for sustainability, infrastructure readiness, and community benefit. In Gloucestershire, where land availability is constrained by AONBs (National Landscapes) and Green Belt protections, (in addition to the River Severn flood plain) this approach offers a viable path to delivering housing while minimizing the impact on more sensitive landscapes.

- 28. Do you agree with the proposed change to paragraph 154g of the current NPPF to better support the development of previously developed land (PDL) in the Green Belt?

  Yes.
- 29. Please explain your answer to the previous question.

  Supporting the development of PDL within the Green Belt, when appropriately managed, aligns with sustainable development goals and helps protect undeveloped land. However, strict criteria are necessary to prevent misuse and to ensure that such developments maintain the environmental and social value of the Green Belt. Prioritizing PDL development can alleviate pressure on greenfield sites, but it is essential to safeguard against inappropriate use. In Gloucestershire, areas like the Cotswolds and Stroud require careful management to balance the need for housing with landscape preservation. Any development in the Green Belt should demonstrate clear public benefit, integrate with existing infrastructure, and enhance community well-being.
- 30. Do you have any views on expanding the definition of PDL, while ensuring that the development and maintenance of glasshouses for horticultural production is maintained?
  Yes, but expansion must be limited to ensure that it does not compromise the primary purpose of the Green Belt. The definition should include clear

primary purpose of the Green Belt. The definition should include clear parameters, allowing only developments that align with sustainability goals, preserve rural character, and do not negatively impact the county's agricultural or horticultural uses.

- 31. Do you agree with our proposed definition of grey belt land? Yes.
- 32. Do you agree with setting the expectation that local planning authorities should consider the particular needs of those who require Social Rent when undertaking needs assessments and setting policies on affordable housing requirements?

  Yes.

Addressing the need for Social Rent housing is critical, especially in areas with high housing costs like Gloucestershire. Local planning authorities should prioritize Social Rent provision in their assessments to ensure that affordable housing strategies meet the needs of the most vulnerable populations. Social Rent housing is often the most effective solution for addressing affordability issues in high-cost areas. In rural regions, where market prices are often inflated by second-home ownership and tourism, prioritizing Social Rent is essential to maintaining diverse and sustainable communities. Local plans should be required to include clear strategies for delivering Social Rent homes.

# 34. Do you agree with removing the requirement to deliver 10% of housing on major sites as affordable home ownership? Yes.

#### 35. Please explain your answer to the previous question.

The focus must shift towards other forms of affordable housing, such as Social Rent, which better meet the needs of low-income families. The 10% requirement can be restrictive and may lead to developments that prioritize home ownership over rental options, reducing the flexibility needed to address local housing needs. Affordable home ownership is important, but it should not be the primary focus on all major sites, especially where the need for Social Rent or other affordable tenures is more pressing. In Gloucestershire, where affordability varies widely between regions, a more flexible approach is needed to tailor affordable housing delivery to local demand.

### 36. Do you agree with removing the minimum 25% First Homes requirement?

Yes.

#### 37. Please explain your answer to the previous question.

The 25% requirement may not always align with local needs, particularly in rural or high-cost areas where rental affordability is a greater priority. Local authorities should have the flexibility to allocate affordable housing according to the specific needs identified in their communities. First Homes are an important part of the affordable housing mix, but rigid quotas can limit the ability of councils to respond to local priorities. In areas like the Cotswolds, where house prices are exceptionally high, the emphasis should be on affordable rental options rather than ownership models that may still be out of reach for many.

### 38. Do you have any other comments on retaining the option to deliver First Homes, including through exception sites?

First Homes should remain an option, particularly in areas with strong demand for home ownership. However, exception sites should be carefully managed to avoid inappropriate developments in sensitive locations, such as AONBs (National Landscapes) or Green Belt land. Local flexibility is key to ensuring that First Homes are delivered where they are most needed.

# 39. Do you agree with introducing a policy to promote developments that have a mix of tenures and types? Yes.

#### 40. Please explain your answer to the previous question.

A diverse mix of tenures and housing types is essential for creating balanced, resilient communities. Local plans should encourage developments that provide a range of options, from affordable rental housing to accessible home ownership, ensuring that housing meets the needs of different demographics and income levels. Mixed-tenure developments contribute to social diversity and help build stronger communities. In Gloucestershire, where housing needs vary significantly between urban and rural areas, promoting a range of tenures is crucial for addressing affordability and ensuring that new developments cater for all sections of society.

### 41. What would be the most appropriate way to promote high percentage Social Rent/affordable housing developments?

Incentives for developers, such as grant funding or reduced planning fees, could be effective in promoting Social Rent housing. Local authorities should also have the power to set higher affordable housing requirements in areas of high need, supported by robust viability assessments to ensure that developments remain deliverable.

# 42. What safeguards would be required to ensure that there are no unintended consequences? For example, is there a maximum site size where development of this nature is appropriate?

Safeguards could include clear design standards to ensure high-quality, mixed-tenure developments, and planning conditions that require community engagement. Maximum site sizes may be necessary to prevent large, isolated developments that lack integration with existing communities. Smaller, well-integrated schemes are often more successful in delivering affordable housing that meets local needs.

### 43. What measures should we consider to better support and increase rural affordable housing?

Supporting rural affordable housing could involve simplifying the planning process for small-scale developments, offering financial incentives to landowners, and prioritizing the conversion of existing buildings. Additionally, promoting community-led housing initiatives, such as Community Land Trusts, (like the English Rural Housing Association) can help deliver affordable homes tailored to local needs.

### 44. Do you agree with the changes proposed to paragraph 63 of the existing NPPF?

Yes.

#### 45. Please explain your answer to the previous question.

The changes provide clearer guidance on affordable housing delivery, aligning planning policies with local needs assessments. Ensuring that

affordable housing is genuinely affordable and meets the specific needs of each community is critical, particularly in rural and high-cost areas. The revised paragraph 63 better reflects the need for flexibility in how affordable housing is delivered, allowing local authorities to prioritize the types of housing that are most needed in their areas. In Gloucestershire, where market dynamics vary widely, this flexibility is essential for delivering housing solutions that align with local affordability challenges.

46. Do you agree with the proposed changes to community-led housing, such as removing size limits for community-led exception sites?

Yes.

#### 47. Please explain your answer to the previous question.

The above response is 'yes' but with caution. Removing size limits could enable more ambitious community-led developments, which are often better aligned with local needs. However, safeguards are necessary to ensure that such developments remain community-focused and do not become vehicles for speculative development. Community-led housing can deliver high-quality, locally tailored solutions, but it is essential to maintain the integrity of these schemes. Size limits should be flexible, but developments must remain proportionate to the community they serve and aligned with local planning objectives. Allowing larger developments should only be considered where there is clear community support and a robust business case.

48. Do you have views on whether the definition of 'affordable housing for rent' in the Framework glossary should be amended? If so, what changes would you recommend?

Yes. The definition should be clarified to ensure that affordable housing for rent is genuinely affordable, based on local income levels rather than a percentage of market rent. In areas like Gloucestershire, where market rents are high, linking affordability to local earnings would ensure that rental housing is accessible to those most in need.

49. Do you have views on why insufficient small sites are being allocated, and on ways in which the small site policy in the NPPF should be strengthened?

Small sites are often overlooked due to perceived viability issues and a preference for larger, more profitable developments. Strengthening the small site policy could involve offering incentives for small-scale developments, simplifying the planning process, and requiring local plans to allocate a proportion of housing on small sites.

- 50. Do you agree with the proposals to retain references to well-designed buildings and places, but remove references to 'beauty' and 'beautiful' and to amend paragraph 138 of the existing Framework?

  Yes.
- 51. Please explain your answer to the previous question.

While design quality is crucial, the term 'beauty' is subjective and difficult to enforce through planning policy. The focus should be on high-quality,

contextually appropriate design that enhances community character and meets functional needs, rather than on aesthetic judgements that may vary widely. The concept of 'beauty' is too subjective to be a practical planning criterion. By focusing on well-designed places that reflect local character, the NPPF can better support developments that integrate with their surroundings and contribute positively to the community. In Gloucestershire, where architectural styles and landscape settings vary significantly, it is important to maintain flexibility in design standards.

### 52. Do you agree with proposed changes to policy for upwards extensions? Yes.

#### 53. Please explain your answer to the previous question.

The extensions must be sensitive to the character of the area and avoid negative impacts on neighbouring properties. In denser urban areas, upwards extensions can be an effective way to increase housing supply without consuming more land. However, clear guidelines are needed to ensure that these developments are in keeping with local architectural styles and do not overshadow or detract from the existing streetscape. Upwards extensions can be a sustainable solution in areas where land availability is limited, but they must be carefully designed to fit the local context. In Gloucestershire, where many areas have distinct architectural identities, design codes should ensure that new extensions do not clash with the character of historic or conservation areas. Additionally, considerations regarding light, privacy, and overlooking of adjacent properties must be addressed to protect the amenity of existing residents.

### 54. Do you have any other suggestions relating to the proposals in this chapter?

While promoting upwards extensions is beneficial, the NPPF should also consider the cumulative impacts of such developments, particularly in areas with limited infrastructure. Local planning authorities should have the discretion to impose height limits and require design standards that reflect the area's character. Community engagement should also be prioritized to ensure that residents are supportive of such developments. The recent Street Vote proposals might be a consideration here.

### 55. Do you agree with the changes proposed to paragraphs 86b) and 87 of the existing NPPF?

Yes.

#### 56. Please explain your answer to the previous question.

The changes provide clearer guidance on retail and town centre development, ensuring that new developments contribute positively to the vitality of town centres. By emphasizing mixed-use developments and encouraging flexibility in town centre uses, the revised paragraphs help support the regeneration of high streets while adapting to changing consumer habits. The retail landscape has shifted dramatically, with more people shopping online and less demand for traditional high street retail space. The proposed changes to paragraphs 86b) and 87 acknowledge this shift by promoting flexible, mixed-use

developments that can adapt to evolving needs. In Gloucestershire, town centres like Gloucester and Cheltenham could benefit from these more flexible policies, enabling a broader mix of uses, including residential and leisure, to revitalize struggling high streets.

### 57. Are there other sectors you think need particular support via these changes? What are they and why?

Yes, the agricultural and rural economy sectors need more explicit support, particularly in rural regions like Gloucestershire. Planning policies should promote diversification in these areas, including support for farm diversification, rural tourism, and small-scale food production. By offering greater flexibility for rural businesses, local economies can be strengthened while maintaining the character and sustainability of rural communities.

58. Would you support the prescription of data centres, gigafactories, and/or laboratories as types of business and commercial development which could be directed into the Nationally Significant Infrastructure Projects (NSIP) consenting regime?

Yes.

#### 59. Please explain your answer to the previous question.

These developments are essential to the UK's economic future and can be better coordinated under the NSIP regime. However, careful consideration must be given to their location and environmental impact, particularly in rural areas like Gloucestershire where large-scale developments could conflict with local priorities. Data centres, gigafactories, and laboratories play a key role in supporting economic growth and technological innovation. However, these facilities often require substantial land and infrastructure, which may not be readily available in all regions. The NSIP regime can streamline the planning process for strategically important projects while ensuring that their development is aligned with national priorities and local planning objectives.

60. If the direction power is extended to these developments, should it be limited by scale?

Yes.

61. Do you agree with the changes proposed to paragraph 100 of the existing NPPF?

Yes.

62. Please explain your answer to the previous question.

The revised paragraph provides clearer guidance on planning for sustainable transport, ensuring that development is more closely aligned with accessible and low-carbon travel options. By integrating transport considerations into the early stages of planning, the changes help promote more sustainable communities and reduce reliance on private vehicles. Sustainable transport is a key component of reducing carbon emissions and creating more liveable communities. In Gloucestershire, where rural connectivity is a challenge, it is vital that new developments are planned with access to public transport, cycling, and walking routes in mind. The changes to paragraph 100 will help

ensure that transport infrastructure is a central consideration in planning decisions, leading to better-connected and more sustainable developments.

### 63. Do you agree with the changes proposed to paragraph 99 of the existing NPPF?

Yes.

#### 64. Please explain your answer to the previous question.

The changes recognize the importance of green infrastructure and open spaces in promoting health and well-being, particularly in urban and suburban developments. By prioritizing access to useable, high-quality open spaces, the revised paragraph supports the creation of healthier, more resilient communities. Access to green spaces is vital for physical and mental health, particularly in densely populated urban areas. The revised paragraph 99 ensures that planning decisions take into account the need for accessible and well-maintained open spaces, which are essential for community well-being. In Gloucestershire, where natural landscapes are a defining feature, preserving and enhancing green infrastructure should be a priority in all new developments.

### 65. Do you agree with the changes proposed to paragraphs 114 and 115 of the existing NPPF?

Yes.

#### 66. Please explain your answer to the previous question.

The changes provide clearer guidance on managing flood risk, ensuring that developments are better protected from flooding and that flood risk is minimized. This is particularly important in areas like Gloucestershire, where flood risk is a significant concern due to the region's topography and river systems. Flood risk management is critical in planning decisions, especially in regions prone to flooding. The revised paragraphs 114 and 115 place greater emphasis on sustainable drainage systems (SuDS) and integrating flood risk management into the design of new developments. In Gloucestershire, these measures are essential for protecting communities, particularly those in the Tewkesbury area affected by the River Severn, from the increasing risk of flooding due to climate change.

67. How could national planning policy better support local authorities in (a) promoting healthy communities and (b) tackling childhood obesity? National policy should encourage active transport, such as walking and cycling, and require developments to include accessible green spaces and recreational facilities. It should also support the integration of community gardens, local food production, and healthier food environments in planning decisions. In Gloucestershire, where rural communities face challenges in accessing amenities, promoting active lifestyles through thoughtful design is key.

### 68. Do you have any other suggestions relating to the proposals in this chapter?

National policy should place greater emphasis on integrating health impact

assessments into the planning process, ensuring that developments minimise negative environmental impacts and contribute positively to public health. Encouraging developments that support active lifestyles, access to nutritious food, and mental well-being will help build healthier communities across the country.

### 69. Do you agree that large onshore wind projects should be reintegrated into the NSIP regime?

Yes.

#### 70. Please explain your answer to the previous question.

Large-scale renewable energy projects, such as onshore wind, are critical for achieving net-zero targets and should benefit from a streamlined approval process under the NSIP regime. This would help overcome local opposition and speed up the deployment of clean energy infrastructure. The NSIP regime is well-suited to managing large, strategically important projects that require coordination across multiple regions. Onshore wind projects are essential for decarbonizing the UK's energy system, and streamlining their approval process will accelerate their delivery. However, it is important that local communities are consulted and that environmental impacts are carefully managed.

# 71. Do you agree with the proposed changes to the NPPF to give greater support to renewable and low carbon energy? Yes.

#### 72. Please explain your response to the previous question.

The changes reflect the urgent need to transition to low-carbon energy sources and provide clearer guidance for planning authorities to prioritize renewable energy developments. This is essential for meeting climate targets and ensuring that the planning system supports the decarbonization of the economy. Supporting renewable energy through the planning system is critical for achieving national and local climate goals. In regions like Gloucestershire, where there are significant opportunities for onshore wind and solar, the proposed changes will help facilitate the deployment of clean energy projects while ensuring that environmental and community impacts are carefully managed.

# 73. Should additional protections for habitats such as peat soils be introduced due to their role in carbon sequestration? Yes.

#### 74. Please explain your answer to the previous question.

Peat soils are vital carbon sinks and play a critical role in mitigating climate change. Additional protections should be introduced to prevent their degradation and ensure that development does not undermine their carbon storage potential. Peatlands are among the most effective carbon stores, but they are also highly vulnerable to disturbance. Protecting these habitats is essential for meeting climate targets and preserving biodiversity. In planning decisions, the preservation and restoration of peatlands should be a priority,

with strict controls on development that could impact these sensitive ecosystems.

- 75. Do you agree that the threshold for onshore wind projects to be deemed Nationally Significant should be changed from 50MW to 100MW? Yes.
- 76. Do you agree that the threshold for onshore wind projects to be deemed Nationally Significant should be changed from 50MW to 100MW?

  The 100MW threshold strikes a practical balance, allowing significant projects to progress more efficiently through the planning system while still permitting community involvement and local authority oversight on smaller wind projects. In Gloucestershire, where landscape and community character are important, maintaining local control for smaller developments ensures that environmental and social factors are fully considered. Raising the threshold allows more projects to benefit from streamlined approval processes under the NSIP regime, while ensuring that smaller projects remain within local planning control. This balance supports the rapid deployment of renewable energy while maintaining local oversight where appropriate, without compromising local autonomy where smaller developments are concerned.
- 77. Do you agree that the threshold for solar projects to be deemed Nationally Significant should be changed from 50MW to 150MW? Yes.
- 78. Please explain your answer to the previous question.
  - Solar energy is critical for decarbonization, and raising the threshold to 150MW will streamline the development of larger projects, which are essential for meeting renewable energy targets. Smaller solar installations, which are often more integrated into local communities, should continue to be managed at the local planning level. Raising the threshold for solar projects aligns with the need to deliver large-scale renewable energy infrastructure rapidly while ensuring that smaller, community-led projects remain within local control. In rural areas of Gloucestershire, this allows for more flexibility in integrating solar farms into the landscape while advancing significant energy generation initiatives. However, while the importance of delivering renewable energy infrastructure is recognised, the Gloucestershire landscape includes traditional Cotswold villages as well as significant Green Belt land and AONBs (National Landscapes. Care must therefore be taken to create a balance between the need to provide renewable energy and the need to protect the county's unique landscape.
- 79. Do you think that alternative thresholds should apply to onshore wind and/or solar, and what would these be? Please explain your answer. Alternative thresholds should be considered based on the local context and potential impacts. For onshore wind, a threshold of 75MW could be more appropriate, balancing the need for larger-scale projects while maintaining local oversight for smaller developments. For solar projects, a threshold of 100MW is more suitable, as larger installations typically require more significant infrastructure and landscape considerations. These adjusted

thresholds would allow for streamlined processes for large, impactful projects while retaining local authority control over smaller, community-scale developments.

### 80. How could national planning policy do more to address climate change mitigation and adaptation?

National planning policy should mandate climate impact assessments for all major developments, enforce strict carbon reduction targets, and promote nature-based solutions such as rewilding and biodiversity net gain. Additionally, integrating climate resilience into local plans and prioritizing low-carbon transport and energy infrastructure: particularly EV charging points, are essential steps for building climate-resilient communities.

# 81. What is your view on the current state of technological readiness and availability of tools for accurate carbon accounting in plan-making and planning decisions?

While tools for carbon accounting are improving, there is still a gap in the standardization and integration of these tools across planning authorities. Investment in training and accessible digital platforms is needed to ensure accurate and consistent carbon assessments. National policy should mandate the use of recognized tools for assessing both operational and embodied carbon in developments.

### 82. Are any changes needed to policy for managing flood risk to improve its effectiveness?

Yes.

#### 83. Please explain your answer to the previous question.

Policies should prioritize natural flood management techniques, enhance requirements for sustainable drainage systems (SuDS), and mandate comprehensive flood risk assessments that account for climate change projections. In Gloucestershire, where flood risk is a pressing concern, stronger integration of flood management within local plans is crucial for community resilience. Managing flood risk effectively requires a combination of hard infrastructure and natural solutions. Policies should emphasize upstream catchment management, reforestation, and wetland restoration to reduce downstream flood impacts. In flood-prone areas of Gloucestershire, particularly those affected by the River Severn in Tewkesbury Borough, improved coordination between local authorities, landowners, and developers is essential to deliver integrated flood resilience measures.

### 84. Do you have any other comments on actions that can be taken through planning to address climate change?

Planning policy should encourage the retrofitting of existing buildings with energy efficiency measures, support district heating schemes, and promote community energy projects. Local planning authorities should also ensure that all housing and shopping developments include adequate EV charging points to meet local need. Every new dwelling must have its own individual EV charging point. Additionally, green infrastructure, such as tree planting and

urban greening, should be prioritized in all new developments to support carbon sequestration, cooling, and biodiversity.

# 85. Do you agree with the proposed removal of text from the footnote regarding agricultural land used for food production? No.

#### 86. Please explain your answer to the previous question.

The availability of agricultural land for food production is critical for local food security and sustainability. Retaining this consideration in planning decisions helps protect high-quality agricultural land from being lost to development, while ensuring that the UK maintains a resilient food supply. In regions like Gloucestershire, where farming is a significant part of the local economy and landscape, safeguarding agricultural land is essential. Removing this text could lead to an increase in the loss of productive farmland to development, which would be detrimental to both local communities and the environment.

### 87. Are there other ways to ensure that development supports food production?

Yes. Policies should promote the protection of Grade 1 and 2 agricultural land, encourage local food production initiatives, and integrate urban agriculture into planning for new developments. Community-supported agriculture (CSA) schemes, allotments, and green roofs could be further incentivized to enhance food security and local resilience.

### 88. Should the government improve water infrastructure provisions in the Planning Act 2008?

Yes.

#### 89. Do you have specific suggestions for how best to do this?

The current water infrastructure provisions are insufficient to meet the demands of growing populations and changing climate conditions. Planning policy should prioritize investment in sustainable water management systems, including rainwater harvesting, greywater recycling, and enhanced reservoir capacity, to ensure a secure water supply for both urban and rural communities. I Integrated water management strategies that involve collaboration between water companies, local authorities, and developers should be encouraged. Mandating water efficiency standards in new developments and retrofitting existing buildings with water-saving technologies can also help alleviate pressure on water resources, particularly in areas like Gloucestershire, where seasonal droughts are increasingly common.

### 90. Are there other areas of the water infrastructure provisions that could be improved?

Yes.

91. Do you agree that the government should replace existing intervention policy criteria with the revised criteria set out in this consultation? Yes.

#### 92. Please explain your answer to the previous question.

The revised criteria offer clearer and more robust guidelines for government intervention, ensuring that housing delivery remains on track while allowing local authorities the flexibility to adapt plans according to local conditions and needs.

93. Would you support the government withdrawing the criteria and relying on existing legal tests for future use of intervention powers?

No.

#### 94. Please explain your answer to the previous question.

The current legal tests are too general and do not provide the level of clarity needed to guide when and how interventions should occur. The proposed criteria are more specific and ensure that interventions are targeted and proportionate, focusing on areas where they can make the most significant impact. Relying solely on existing legal tests could lead to inconsistent and potentially arbitrary interventions, undermining the planning system's effectiveness. The proposed criteria provide a clear framework for when interventions are justified, ensuring that they are based on objective measures of performance rather than subjective judgement.

95. Do you agree with the proposal to increase householder application fees to meet cost recovery?

Yes.

- 96. Do you support increasing the fee by a smaller amount?
- 97. Do you agree with the proposed transitional arrangements? Yes.

#### 98. Please explain your answers to the previous questions.

The proposed transitional arrangements provide a reasonable timeframe for local planning authorities and developers to adjust to the new fee structures. This phased approach minimizes disruption and allows stakeholders to plan accordingly while ensuring that resources are made available to support improved planning services. The current fee structure does not cover the full costs of processing applications, leading to delays and under-resourced planning departments. By increasing fees and implementing transitional arrangements, local authorities can enhance service delivery while giving applicants time to adjust to the new costs.

- 99. Are there any alternatives you think should be considered? Yes.
- 100. **Do you agree with the proposed transitional arrangements?** Yes.

#### 101. Please explain your answer to the previous question.

The transitional arrangements are necessary to ensure that planning authorities and applicants can adapt to the changes in a structured and manageable way. This minimizes the risk of disruption while ensuring that fee increases are implemented effectively. Gradual implementation of the new fees allows planning authorities to plan for increased staffing and resources while giving developers and homeowners time to factor the new costs into their budgets. This phased approach balances the need for additional resources with the importance of minimizing shock to the system.

### 102. Do you have any other suggestions relating to the proposals in this chapter?

Consider offering incentives or discounts for developments that align with local sustainability goals, such as incorporating energy-efficient designs or providing community benefits. Additionally, introducing performance metrics linked to fee levels could help ensure that planning departments remain accountable for delivering high-quality services.

# 103. Do you have any views on the impacts of these proposals for you, or the group or business you represent, particularly for those with protected characteristics?

The proposals could have both positive and negative impacts on different groups. On the positive side, increasing planning fees and streamlining processes may lead to faster decisions and better resourced services. However, care must be taken to ensure that fee increases do not disproportionately affect small businesses, low-income applicants, or community groups who rely on affordable access to the planning system

### Cornhill/Market Tavern development site

#### 3.3.2 *Introduction:*

Following the closure of The Market Tavern public house an opportunity has opened up for a new major development in the heart of the town. The site is in an important location at the junction of London Road, Cornhill and Union Street opposite Brunel Mall multi-storey car park.

#### Objectives:

- Diversify the economy

- Welcome and support new and existing businesses and provide a good range of high quality accommodation for businesses, including social and cultural enterprises to establish and grow.
- Optimise opportunities to develop or redevelop land within the town centre to meet the needs of the town and make the most efficient use of land and buildings.

#### Policy ZP1b Cornhill/Market Tavern site


Any scheme for the redevelopment of The Market Tavern and adjoining land as shown on the proposals map that provides the following will be supported:

- Retail use on the ground floor fronting Union Street, incorporating window displays along Union Street and access from Union Street.
- Protection and enhancement of the markets located in and adjacent to Cornhill.
- A high quality 'landmark' building creating a striking frontage to the London Road/Cornhill 'gateway', which recognises and respects the important heritage assets and related contextual considerations associated with the site.
- Improved pedestrian accessibility at the London Road/ Cornhill junction and to the Brunel Mall car park.
- Contributions to the improvement of pedestrian accessibility from London Road car park where relevant to the development.
- Contributions to improvements to the public realm within the area of the Core Zone impacted by the development.

The site is suitable for a significant addition to the retail floor space in the centre and some residential and/or commercial use on upper floors.

#### Explanation:

This is a good location for increased retail floorspace in the Core Zone close to the Brunel Mall car park which normally has significant spare capacity serving the town centre. The site has the capacity to accommodate a medium-sized retail unit which would enhance the attractiveness of the centre, increase footfall and boost the role of the centre. Development of the site would also offer the opportunity to integrate the market square, which is currently underused, with the main network of streets in such a way as to enhance the operation of the Farmers' Market, and the potential for other markets during the week. Residential or commercial accommodation in this area would add to the vitality of the town centre.

The marked bays will be enforced to ensure that they are only used by EV drivers. The others will be a courtesy bay where non-EV drivers can park, but we would ask that they keep these clear if other bays are available. We will monitor demand for EV charging and mark out the 3<sup>rd</sup> bay later as demand picks up.

#### **Barrowfield Road latest communication**

Good afternoon Helen.

I'm sorry to learn that STC have been unable to reach agreement with local residents over the future maintenance of this gateway area to Barrowfield Rd – certainly Highways would have approved a cultivation licence for STC to dress up the entrance to the road to something more aesthetically pleasing.

Although the resurfacing request of the slabbed areas was noted at the time, there are no current plans to carry out any surface improvement works here from our very limited budget. I'm happy to raise a job for the area to be strimmed of weed growth but that is the limit of resource we can currently employ to this location.

In terms of bollards, Gloucestershire County Council's policy is not to install new bollards/marker posts where they do not already exist unless there is a known safety issue which is supported by accident data. This approach is taken due to the maintenance liability of increased street furniture and limited resources for non-safety related work, and applies to paved and grassed areas. There is the Trees for Streets initiative which you may want to look into - Let's fill Gloucestershire with trees - Trees for Streets. If any subsequent application was successful, we would have to carefully consider the position of trees here so they don't present a road safety issue, but something certainly worth investigating.

#### **Purpose of Report**

- 1.1. To provide background information on the proposed Traffic Regulation Order (TRO) entitled above.
- 1.2. To provide details of representations made in relation to the TRO. A copy of the representations received is included in the appendices at the end of this report.
- 1.3. To make a recommendation to the Traffic Regulation Order Manager on the way forward.

#### 2. Recommendation

- 2.1. That, for the reasons given in this report and after consideration of the representations made, GCC now:
  - Makes the TRO with a modification to the proposed Disabled Badge Holders Only restriction hours to ensure the Taxi Rank Provision is retained in the evenings as existing. The restriction will, therefore, be Disabled Badge Holders Only 3 Hours No Return 2 Hours 7.30am-6.30pm/No Waiting Except Taxis 6:30pm-7:30am (next day)

#### 3. Background and Purpose of the Scheme

- 3.1. It is proposed to convert a section of the existing Loading Only 7:30am-6:30pm/No Waiting Except Taxis 6:30pm-7:30am bay into a Disabled Badge Holders Only 3 Hours No Return 2 Hours Bay.
- 3.2. The Stroud Library is being relocated from its current location in Lansdown to the Five Valleys Shopping Centre. The location of the library is to be on a lower ground floor adjacent to a new GP surgery and come with a new ground level frontage, staircase and robust bed and fire evacuation lift, making it more accessible to visitors and staff. The Gloucestershire County Council Assistant Director of Traffic & Transport has raised a request for disabled parking measures on King Street, Stroud in association with the relocation of the Stroud Library. This is in order to provide disabled parking near to the entrance to the relocated library, as there is currently no on-street disabled parking provision on this street. The bays will also benefit disabled badge holders to access shops in the local area.

#### 4. Law and Policy

- 4.1. The Road Traffic Regulation Act 1984 sets out the legal basis for making TROs. The proposal meets with Section 1 of the Road Traffic Regulation Act 1984 which allows GCC to make an order to:
  - avoid danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising; and

- for facilitating the passage on the road or any other road of any class of traffic (including pedestrians).
- 4.2. Thorough consideration has been given to the factors set out in Section 122 of the Road Traffic Regulation Act 1984 in proposing this TRO. This requires the local authority to secure the expeditious, convenient and safe movement of traffic (including pedestrians). In carrying out this exercise GCC must have regard to the:
  - a) Desirability of securing and maintaining reasonable access to premises.
  - b) The effect on the amenities of any locality effected and (without prejudice to the generality of this paragraph) the importance of regulating and restricting the use of roads by heavy commercial vehicles, so as to preserve or improve the amenities of the areas through which the road(s) run.
  - c) The strategy prepared under Section 80 of the Environment Act 1995 (the national air quality strategy).
  - d) The importance of facilitating the passage of public service vehicles and of securing the safety and convenience of persons using or desiring to use such vehicles.
  - e) Any other matters appearing to the local authority to be relevant.
- 4.3. Any changes are made in accordance with the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996. Under this procedure authorities are expected to consult local community groups and the Police together with other organisations listed where appropriate, such as the other emergency services and transport operators.
- 4.4. GCC is required to advertise the draft TRO it intends to make, to allow a period for representations of support or objection to be submitted. After this consultation, GCC must consider any representations received and having done so, to either:
  - a) Resolve to make a TRO in the form originally intended and advertised; or
  - b) Modify the TRO from the originally advertised and re-consult where necessary; or
  - c) Abandon the proposal altogether.
- 4.5. Significant modifications to the proposed TRO would need to be consulted on with those that maybe affected to provide further opportunity for representations to be made.
- 4.6. Traffic Authorities have the flexibility to implement restrictions that are appropriate for an individual road, reflecting safety and road user needs whilst taking into account all local considerations.

#### 5. Traffic Data

5.1. There have been two recorded traffic collisions where the restrictions are proposed in the previous five years. Of these one appears to be as a result of an altercation between a taxi driver and customer. The other was an elderly pedestrian collision with a vehicle. However, this would appear to be an isolated incident given that there have been no other recorded collisions of a similar nature in the past five years. Collision Data can be found in Appendix F.

#### 6. Consultation on the proposed TRO

6.1. Public consultation (Notice of Proposal) together with consultation with the statutory consultees was undertaken between 18<sup>th</sup> January 2023 and 10<sup>th</sup> February 2023 with Notices placed on site and delivered to directly affected properties, in the local newspaper (Stroud

News & Journal), on the County Council's website and on deposit at various locations (see Appendix A & B). Following the conclusion of the consultation, all objectors were provided with a response to their objection and given a further 21 days to uphold their objection. The representations made can be found in Appendix C.

#### 7. Objections/Support

7.1. The Statutory Consultees responded as follows:

7.2. Other responses received during the Public Consultation (Notice of Proposal):

Three responses were received. Of these, one was in support for the proposal and the other two were both objections to the proposal, of which both were upheld.

#### 8. Details of Upheld Objections and Case Officers Response

- 8.1. The objectors did not state an objection to the principle of additional disabled parking provision. However, they objected by stating that proposal was on the wrong side of the road and persons with limited mobility would struggle to cross King Street to access the redeveloped Library and the town. They stated King Street is a busy road with poor visibility and no pedestrian crossing. They requested that the Taxi rank be shortened by 1 space to create a disabled parking bay on the northern side of King Street.
- 8.2. In response to the objections, the scheme has come about in order to provide disabled parking near to the entrance to the relocated library, as there is currently no on-street disabled parking provision on this street. The bays will also benefit disabled badge holders to access shops in the local area.

The consultation feedback and suggestions for putting the disabled bay on the north side of King Street closer to the GP surgery have been reviewed. However, when analysing the suggestions from the consultation against the current proposal, it is important that consideration is given to the operation of the taxi rank.

Due to a higher turnover this will serve a larger number of people visiting the town centre and retaining the taxi rank outside the GP surgery is advantageous for vulnerable people accessing the GP surgery – older, younger and those with disabilities. It is also safer for Taxi passengers to board or alight from the nearside pavement, where they can access front and

back seats. Given the one-way nature of the road and the location of the proposed Disabled Bay on the southern side of King Street, a disabled driver will be entering/egressing their vehicle from the footway side, rather than into the carriageway, reducing the risk to them.

The proposed disabled bay is located close to an existing dropped crossing (by the corner of King Street/George Street). It is also close to another existing disabled bay on George Street. The provision of tactile paving, the one-way operation and single traffic lane combine to mitigate the risk to pedestrians crossing here.

Therefore, it is imperative the proposed disabled bay remains where it was originally proposed, to manage the parking provision on-street in the most suitable way whilst minimising disruption to the existing parking arrangements and operation of the Taxi rank.

#### 9. Modification

9.1. Following the formal public consultation for the TRO, an amendment has been made to the operating hours of the Disabled Badge Holders Only restriction to allow Taxi Rank provision in the evenings as per the existing restrictions. This means that the restriction is now proposed as Disabled Badge Holders Only 3 Hours No Return 2 Hours 7.30am-6.30pm/No Waiting Except Taxis 6:30pm-7:30am (next day). In reality, the Disabled Badge Holders Only Restriction will be a straight swap to replace the existing Loading Bay restriction. This is not deemed to be a significant modification so no further consultation is required. The Proposal Plan showing this modification can be found in Appendix E.

#### 10. Equality Impact Assessment

10.1. GCC has given due regard to the 3 aims of the general equality duty under the Equalities Act 2010 in relation to the 9 groups (Age, Disability, Sex, Race, Gender reassignment, Marriage and Civil partnership, Pregnancy & Maternity, Religion and/or Belief and Sexual orientation, along with other groups (such as long term unemployed, socio-economical deprived groups, community cohesion, human rights)) with protected characteristics and its decision to make this TRO permanent does not adversely affect any of the groups with those protected characteristics. The introduction of a day-time Disabled Badge Holder Only restriction will benefit those less able to access the new library (please see Due Regard Statements in Appendix D).

#### 11. Summary

- 11.1. It was proposed to convert a section of the existing Loading Only 7:30am-6:30pm/No Waiting Except Taxis 6:30pm-7:30am bay into a Disabled Badge Holders Only 3 Hours No Return 2 Hours Bay.
- 11.2. The Stroud Library is being relocated from its current location in Lansdown to the Five Valleys Shopping Centre. The location of the library is to be on a lower ground floor adjacent to a new GP surgery and comes with a new ground level frontage, staircase and robust bed and fire evacuation lift, making it more accessible to visitors and staff. The Gloucestershire County Council Assistant Director of Traffic & Transport has raised a request for disabled parking measures on King Street, Stroud in association with the relocation of the Stroud Library. This is in order to provide disabled parking near to the entrance to the relocated library, as there is currently no on-street disabled parking provision on this street. The bays will also benefit disabled badge holders to access shops in the local area.

- 11.3. Representations were received during the Notice of Proposal (Public Consultation) process from residents and Stroud Town Council with regards to the proposed restrictions. All representations have been outlined and responded to within this report in Section 8, in alignment with GCC's duty under the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996.
- 11.4. Following the Public Consultation process, the Blue Badge Holder Only restriction operating hours have been amended to ensure the existing Taxi Rank provision is retained in the evenings as existing. Therefore, the Disabled Badge Holders Only Restriction will replace the existing Loading Bay restriction and operate between 7:30am-6:30pm and the Taxi Rank will continue to operate between 6:30pm-7:30am.
- 11.5. In considering the assessment under Section 122 of the Road Traffic Regulation Act 1984, the proposed amended version of the TRO meets GCC's obligations in that they would ensure the expeditious, convenient, and safe movement of vehicular and other traffic and the provision of suitable and adequate parking facilities on the highway.

#### 12. View of the Case Officer

- 12.1. This report demonstrates that the introduction of the proposals is consistent with National Guidance and has been fully consulted upon in accordance with Gloucestershire County Council procedures and followed necessary statutory procedures, as set out in the Local Authorities' Traffic Orders (Procedure) (England & Wales) Regulations 1996.
- 12.2. Three Objections have been upheld from Stroud Town Council and members of the public during the Notice of Proposal (Public Consultation) process and also one in support, which is a small proportion of those consulted throughout the Town. It can therefore be considered that the proposals are deemed to be acceptable to the vast majority.
- 12.3. It is felt that the amended TRO proposal takes into account the Council's duties under Sections 1 and 122 of the Road Traffic Regulation Act 1984 and balances this with the fact that only 3 Objections were received and upheld.
- 12.4. On reviewing the original TRO proposal following the Public Consultation process, the Disabled Badge Holder Only restriction operating hours were amended to ensure the existing Taxi Rank provision is retained in the evenings. Therefore, the Disabled Badge Holders Only Restriction will replace the existing Loading Bay restriction and operate between 7:30am-6:30pm and the Taxi Rank will continue to operate between 6:30pm-7:30am. This is not deemed to be a significant change so no further consultation is necessary.
- 12.5. It is considered that the restrictions proposed meet GCC's objectives and therefore, it would be beneficial that the TRO be made permanent with the amendment to the Disabled Badge Holder Only operating hours as per 12.4 above.

#### 13. Recommendation by the Senior Case Officer

13.1. I am satisfied that the TRO has been correctly advertised and consulted upon in accordance with the Road Traffic Regulation Act 1984 and the procedures laid down in that Act.

- 13.2. The necessary statutory procedures as set out in the Local Authorities' Traffic Orders (Procedure) (England & Wales) Regulations 1996 have been followed, and guidance, including the Traffic Signs Regulations and General Directions 2016 have been considered.
- 13.3. Although 3 objections were upheld to the TRO, I am satisfied that they have been duly considered and responded to and that a balance has been drawn between the upheld objections, amount of on-street disabled parking in the vicinity and safety of all road users.
- 13.4 The amended operating hours of the Disabled Badge Holder Only bay to retain Taxi Rank provision in the evenings is a positive change. This taxi rank is well-used and by making this change, no taxi provision is being lost and will remain as existing. I do not deem this to be a significant change and no further consultation is required.
- 13.5. After considering all background information, representations and data supplied in this report, I recommend that the upheld formal representations are considered as minor in nature.
- 13.6. I recommend that the TRO is made permanent with a modification to the proposed Disabled Badge Holders Only restriction hours to ensure the Taxi Rank Provision is retained in the evenings as existing. The restriction will, therefore, be Disabled Badge Holders Only 3 Hours No Return 2 Hours 7.30am-6.30pm/No Waiting Except Taxis 6:30pm-7:30am (next day).

#### 14. Decision By the Traffic Regulation Order Manager

- 14.1. I have considered the report, recommendations and whether to hold a Traffic Regulation Committee. I have also considered the representations that we have received in relation to this matter in making my decision. I have decided that Gloucestershire County Council should:
  - Make the TRO with a modification to the proposed Disabled Badge Holders Only restriction hours to ensure the Taxi Rank Provision is retained in the evenings as existing. The restriction will, therefore, be Disabled Badge Holders Only 3 Hours No Return 2 Hours 7.30am-6.30pm/No Waiting Except Taxis 6:30pm-7:30am (next day)
- 14.2. As a result of the above I give authorisation for the Assistant Director of Legal Services to act on my decision pursuant to delegations approved in accordance with the Local Government Act 1972 and subsequent legislation.





# Proposed Disabled Badge Holder Parking Bay Provision – King Street, Stroud, Gloucestershire

#### **Proposals**

It is proposed to convert a section of the existing Loading Only 7:30am-6:30pm/No Waiting Except Taxis 6:30pm-7:30am bay into a Disabled Badge Holders Only 3 Hours No Return 2 Hours Bay.

#### Reasons

The Stroud Library is being relocated from its current location in Lansdown to the Five Valleys Shopping Centre. The location of the library is to be on a lower ground floor adjacent to a new GP surgery and come with a new ground level frontage, staircase and robust bed and fire evacuation lift, making it more accessible to visitors and staff. The Gloucestershire County Council Assistant Director of Traffic & Transport has raised a request for disabled parking measures on King Street, Stroud in association with the relocation of the Stroud Library. This is in order to provide disabled parking near to the entrance to the relocated library, as there is currently no on-street disabled parking provision in the vicinity. The bays will also benefit disabled badge holders to access shops in the local area.

# **Road Traffic Regulation Act 1984**

The specific grounds with which the County Council are using for the implementation of the proposed scheme as above are encompassed in the following sections of the Road Traffic Regulation Act 1984 for making a Traffic Regulation Order:

	Thank you for sending me a letter outlining the proposed changes to the on street parking regulations. XXXXXX very busy GP practice which is located at XXXX King Street. Whilst I am pleased to see the provision of disabled parking opposite our building, in my opinion it is on the wrong side of the road and persons with limited mobility will struggle to cross King Street to access our building. King Street is a particularly busy road with poor visibility and has no pedestrian crossing. We have already had a number of patients concerned about this.
	It would be very helpful if the taxi rank could be shortened by 1 space to create either a disabled parking bay or drop off point outside our building. Taxis are still able to park in Rowcroft Retreat and therefore reducing the space on King Street would not impact on their business.
	Response – Upholding Objection: Dear XXXX
	Thank you for your response. The size of the taxi rank outside the surgery, whilst providing a benefit for the town and people visiting the surgery, means that there is no dropping off point outside the surgery. As the taxis queue outside the surgery and into Rowcroft retreat, I wonder whether a solution might be to reduce the size of the rank in King Street by 1 space, creating room for a dropping off point. This would mean that patients with very limited mobility could be dropped off safely, without the need the cross a busy road. I do not agree that it is safe for people with limited mobility to cross the road, as the disabled parking places are place out of site on a corner. In this proposal, the number of taxis working in the town centre would not be reduced, as they would still continue to queue in Rowcroft Retreat.
Stroud Town Council	Stroud Town Council recently considered this TRO and wish to make the following observations:
	The Council supports in principle the proposal for disabled parking spaces but were concerned about the below standard crossing arrangements at the junction and request a crossing from the dropped kerb outside HSBC bank over to the dropped kerb on the other side of the road and outside

Savers. It was felt the proposed additional on street parking will increase the visibility issues and the level of difficulty when crossing.

# **Response – Upholding Objection:**

The Committee reiterated their previous objection.

Following a very recent Simul-Spec walk in the town, this area was specifically highlighted, by blind and partially sighted members of the community, as a dangerous place to cross. This crossing was taken into consideration with the development of the Levelling up Fund bid, so there is a concept plan available. It was suggested Gloucestershire County Council talk to the owners of the Five Valleys centre about providing free disabled parking on the top level of their car park, so people could go down to the surgery in the lift.

The proposal will take away a loading space, which is used regularly, including by NHS services for the collection of blood samples, etc. It also reduces the viability of any potential business looking to take on the former M & Co building.

The proposal is contrary to NDP policy AP3, which states "Creating a visually integrated, uncluttered and fully accessible streetscape for the main retail streets in the town centre taking into account necessary resting places, pedestrian safety, access for those with mobility issues and the needs of people with disabilities". This area is in Town Centre Zone Z1 Core, which is the heart of the shopping area.

Members agreed that although the current taxi rank would be the obvious first choice location, they would prefer the additional parking space to be located in George Street. Whilst cars are parked in the proposed location it is difficult to see the road. Buses and larger vehicles are often stuck on the corner due to difficulty manoeuvring around the King Street/George Street junction. Proper mitigation is also required on the corner to bring down the speed of drivers.

In respect of the matter, the proposed disabled spaces are on the wrong side of the street, and should be outside 1-3 King Street .

This building houses a new GP Practice and NHS Therapy suite and new Stroud Library. All these users require on street disabled parking and given the nature of the medical users, particularly the physiotherapy and podiatry (feet ) suite, by their very nature many of their patients will be of limited mobility.

The taxi rank extends onto a large stand on Rowcroft Retreat which can accommodate 10 cars, although rarely is it used by more than 2.

A disabled or patient drop of bay in front of the medical centre would be the most beneficial location and avoids wheelchair and slow moving people crossing what can be a busy road.

I would be grateful for an acknowledgement, particularly as we have not been consulted which I believe should include the freeholders as well as the occupiers. many thanks

# **Response – Upholding Objection:**

Dear XXXXXX

I am disappointed with the response and wish to uphold our objection .

I do not believe that it considers the needs of the disabled sufficiently and there is perhaps a misunderstanding about the rank and the space that it has.

Can I draw your attention to these key facts :-

- 1. the taxi rank is not just on King Street but extends halfway down Rowcroft Retreat.
- 2. The rank easily holds 10 cars and I have never seen more than 5 on the stand.
- 3. There is NO NEED to relocate the rank.
- 4. 1 less taxi space on King Street Taxi rank will have NO impact on its viability, but will make a major difference to a disabled person.

You should note that XXXX King Street is a multi occupier building and accommodates :-

- 5. a 2 floor, 34 consulting room GP Surgery with over 15000 patients.
- 6. also an NHS Therapy department with 13 consulting rooms for physiotherapy and podiatry (feet) ie for people with mobility problems.
- 7. and will have a major new library facility,
- 8. and a Db bay will also serve shoppers who can more easily access King Street without having to cross a busy road.

Please can we arrange to meet on site ,visit the building and walk the area so that you can understand the size of the rank and how it works .

The statement below suggesting a relocation of the rank is simply incorrect and unnecessary as there is ample space to accommodate a Db bay on the correct side of the road .

Please see the enclosed plan that shows an ambulance bay(or Db bay) immediately in front of the entrance to 1 King Street, and still room for 2 taxi's sitting on King Street, plus all of the Rowcroft Retreat stand.

I do not think it reasonable to ask a person with mobility issues (obviously slow moving) to cross a busy road on a corner when the ideal and obvious place for them to park is opposite, and in doing so will have absolutely no effect on the viability of the rank.

I appreciate that the Taxi lobby is loud but with a properly considered and explained scheme, leaving a large rank on site, I fail to see on what grounds they can object .




