## **REPORT**

## **Biodiversity/Habitats**

- The team held an hour long Big Butterfly Count event at the New Cemetery on Wednesday 24<sup>th</sup> July. Unfortunately due to the weather a low number of butterflies were on display.
- Cinnabar moth (*Tyria jacobaeae*) caterpillars that feed on ragwort (*Senecio jacobaea*) where out in force across our sites this year.
- The beautiful demoiselle damselfly has been recorded at the Long Ground.
- Silver Tree Services were called in to fell a white willow (Salix alba) at the Long Ground that had spilt at about 8m high. The smaller branches were chipped and left on site to be used for mulching beds. The larger pieces and the main stem were also left on site as deadwood habitat.



- Ivy was removed from a rowan tree at Locking Hill to allow a visual inspection of the trees health.
- The rangers attended an afternoon training session on biodiversity organised by Stroud District Council

#### **Burials**

There have been 7 burials and 3 crem burials since the last report.

## **Health and Safety**

- The horticultural ranger has collated what3words locations for all the entrances to our green spaces.
- All staff attended a training session on personal safety and de-escalation.

## **Maintenance and Buildings**

- The hatch was opened up above the Slad Brook at Locking Hill to allow an inspection of the calvert to take place.
- As part of the preparations to move from the depot to Locking Hill the shed in Bank Garden was tidied and rubbish removed to make room for tools and grit from the depot.
- The green shed in the compound at the new cemetery also had a spring clean. New shelving was installed to allow tools and equipment to be stored.
- The District Council are in the process of upgraded the area around the cenotaph in Park Gardens.
- UK Landscapes have carried out 3 cuts at the New Cemetery.
- Stroud Alarms carried out a fire risk assessment at Locking Hill. They also installed a new alarm system.
- The GSM met Tom Sykes the architect for Locking Hill to discuss vehicle locations etc.
- Heras fencing has been put in place at the eastern entrance to Locking Hill to prevent unauthorised parking.
- The GST have cleared up the rubbish left at Locking Hill. The areas around Locking Hill also been cut and unwanted vegetation removed.
- The GST have began taking down partition walls at Locking Hill to create a new depot.





#### Horticultural

- Weeding and watering has been carried out at a number of sites.
- The GST team have tidied up the shrub border on Wood Street next to Stroud Registry Office.
- The horticultural ranger has looked into replacing the 3 round planters on the traffic island at Wallbridge. It is hoped that they can be replaced with self-watering troughs and be incorporated into annual planting scheme.

#### **Community Engagement**

 A chest freezer was moved from the Trinity Rooms to Oakbrook Farm at Wick Street for NoSH by the rangers.

- The team attended Stroud Show on Saturday 13<sup>th</sup> July. This was the first time STC had attended the show for many years as they would usually go to the Festival of Nature which has now finished. The show was well attended and the team recruited 5 volunteers to help with horticultural work.
- The grass was cut, wheelie bins and tug of war rope delivered in preparation for Daisy Day at Daisy Bank.
- The "Sheffield" cycle racks are now installed at Summer Street Allotments.

#### **REPORT**

The refurbishment of the play area in Park Gardens is included in this year's work programme with a budget of £20,000 for replacement play equipment.

A draft tender pack is attached for review. A pre-engagement notice has been published on the government procurement websites Find a Tender and Contracts Finder to stimulate interest in the project from equipment providers.

Given the limited budget for the project a fixed price approach is recommended.

The fence surrounding the play area also needs to be moved slightly to allow for succession planting of trees as approved by the Committee at the meeting on 23/01/2024. This work will be instructed independently of the play equipment work. A quote for the work is attached for information.

# Tender for new play equipment at Park Gardens, Stroud

## Background

Park Gardens is a popular and well-used park on Slad Road in Stroud. It is managed by the Green Spaces Team at Stroud Town Council. The site was gifted to the town in 1920 by Sidney Park, a local businessman, in memory of his 23-year-old son, Herbert, who was killed during the First World War.

The site is home to the town's war memorial and is relatively formal, but it does include a small children's play area. The equipment in this area is coming to the end of its lifespan.

## Aims

The aims of this project are to:

replace and upgrade the existing play structures as pictured:



• move the current fence to make space for succession tree planting



meet the requirements of the Disability Discrimination Act 1995



## **Design Brief**

- The current structure is extremely popular and the proposed replacement should aim to at least replace, or develop further the existing design elements.
- Surfacing should be new wet pour.
- Where practicable, the materials should feel "natural".
- Where practicable, materials and processes of installation should be environmentally sustainable. We would expect details of how a provider will achieve this in their tender.
- All equipment must be certified to meet the British and European Standard for playground equipment and surfacing is BS EN 1176.

The replacement structure will provide play opportunity for the same age range as the current structure; 3-10 years. Key elements of the design will include provision for:

- A good variety of distinct physical play activities to support children's development and enjoyment.
- Opportunities for social interaction through cooperative play, social engagement, and imaginative play.
- Sensory play opportunities, including tactile, auditory, visual experiences; and interaction with natural elements.

## Health and Safety

Please note that the successful bidder will be required to submit a detailed risk assessment and method statement covering all of the works (including any subcontracted work) and waste disposal at least one week before work commences.

## Location and access

Address: Park Gardens, Slad Road, Stroud, Glos. GL5 1QU

<u>Access:</u> Access is not straightforward for the site which is at the top of a sloped park. The site can be accessed by vehicles, but vehicle movements on the site should be kept to a minimum. A public footpath runs close to the site, and should be protected during the works.

Vehicles can be parked at the nearby Council offices.

It is recommended that bidders visit the site to assess the access prior to putting forward a tender.

## RECOMMENDATION

To approve the development of the plant nursery in 2025 subject to any planning consent approvals.

#### **REPORT**

This document attempts to assess the feasibility of installing and running a polytunnel in the New Cemetery compound. It discusses various potential uses and addresses the most important considerations involved in cost, siting, building and running a polytunnel which could benefit the Council and the people of Stroud. A full project proposal has been included as Appendix 9a.

Site size – 10m x 7m (33ft x 23ft)

#### **Potential Uses:**

- Growing food for food hubs thus reducing their costs and providing organic produce for the local community. Increase in community engagement.
- Growing bedding for annual baskets reducing what the Council sources from nurseries, thus reducing costs whilst giving the Council a greater choice of plants.
- **Growing plants for town planters** thus reducing the need to buy from nurseries, increasing plant choice for the Council and also reducing costs.
- Growing plants to sell to public. Direct income.

### **Considerations:**

**Water**. The GST have recently installed guttering on the green shed for rain water collection. This drains into 2 x 1000 litre capacity collection tanks with taps.

If mains water is required as backup supply, there is mains water 20 meters from the location. A shallow trench can be dug to lay a hose connecting a tap in the compound to this mains water supply. This would be most useful if a drip feed irrigation system is being used. This is something which can be added at a later date if needed.

**Electricity.** Electricity is potentially required for lighting. Only going to be needed in winter months if working outside of daylight hours. Most work will be done in daylight hours and during lighter months in the season. No electric needed to power tools or equipment for normal use in a polytunnel. Therefore it

is unlikely that electricity will be vital to the success of a polytunnel. However there also the option of installing solar panels to the green shed roof nearby (not costed).

**Ground**. A big consideration for ground preparation is persistent weeds eg. nettles and, in particular, bindweed. This will need to be suppressed or better still eliminated.

The most effective method for eliminating the bindweed would be to spray it off, though herbicide use is not permitted. A one-off application might be acceptable, but would need to be on a case-by-case basis. This would also reduce ability for bindweed entering into the compost bays (situated next to polytunnel site), which is currently a constant battle. Bindweed in the compost heaps or even growing medium within polytunnel could effectively render them unusable.

Site is mostly level but requires some work to make smooth. \*See below for ground options.

**Building**. GST to build. 3 rangers 3 – 5 days for build and install (depending on ground option). Requires digging holes for anchor plates. GST will have all tools required for the work, aside from a compactor if required for ground work. These can be rented for a small fee.

**Compost/growing medium and feeding**. All compost produced by Green Spaces operations and manure can be sourced if required from Horns farm and kept in existing bays. Organic high potash and high N feeds from tubes already installed in compound. Comfrey and nettles harvested from nearby for this.

Environmental Conditions. Sited in the North East corner of the compound, the polytunnel would receive the most sun. Some shade at some times in the year would come from a large Ash tree (with dieback) and Sycamore on the southern compound boundary. Summer heat requiring management with ventilation. Some shade from nearby trees will help with cooling. Winter temperatures can be particularly cold in this site's micro-climate. Wind would unlikely cause issues. Site has some shelter from hedge, trees, fence and green shed. Good quality polytunnels are robust and uprights are securely anchored into the ground. Deer are present in the Cemetery and browsing would be a consideration in warm weather when doors are open for ventilation.

**Aesthetics.** Polytunnel will be partially visible from higher ground above, mainly in the New Cemetery.

**Hand Tools.** A collection of hand tools can be stored in the compound site safe lockup. Gloves, spades, forks, towels and secateurs. Budget £200 – 300.

**Volunteers.** Community engagement opportunity as it will probably require a volunteering group to assist with the running of the polytunnel and the growing. A group lead could keep a lock code to access compound and tools. Time input could be high and often depending on time of year. There is a compost toilet on site.

#### \*Ground:

Options are **covered ground with benches** *or* **bare soil** *or* a **combination of both**. Depends on use/user requirements.

#### **Covered Ground**

Most appropriate for growing plants for planters, for sale or for containers. Required pots and probably benches (repurposed using the salvaged plastic fence panels in compound). Less bending required for user.

- Type 1 hardcore levelled and compacted (approx. 20 ton = £1000 delivered loose).
- Labour time levelling and compacting aggregate 1 day 2 rangers. Would probably need to rent whacker plater (approx £150 per day).
- Structure to sit on top of this. Inside, weed suppressant membrane (approx. £40) held down by timber batons (roof battens 25mm x 38mm x 4800mm £50 60 pack of 8.

#### Bare Soil

Will only work if persistent weeds are removed. Minimal cost. Most appropriate for growing some types of food. Requires bending/crouching by user.

## FINANCIAL AND STAFFING IMPLICATIONS

#### Financial implications

The total cost of the largest structure from the table below and using prices in this document for ground preparation, building and installing, is £3,100 (including shipping fees).

Ground work cost at approximately £1,400 (not including ranger time).

Other costs can be met from existing budget lines in 2024-25 budget.

Ongoing maintenance can be met from existing budget lines.

If plant sales to the public are progressed the VAT position will need to assessed.

There is potential to seek grant funding for this project, which has yet to be explored.

#### Staffing implications

It is estimated to take 3 rangers 3 – 5 days in total to achieve the initial structure. Ongoing care and maintenance can be met within current staffing levels.

As local leaders in community-based cycling initiatives – founders of Access Bike, The Bike Drop and the Cargo Bikes of Stroud group - we have initially focused on our existing resources, connections, skills and competencies around cycling, to raise awareness and provide practical solutions to low carbon transport in the Town Centre.

- Objective 1 in the same Strategy Document is "A carbon neutral town which recognises the limits of the global environment". The objective involves the commitment to "take active steps where possible to encourage: a) More sustainable transport [among other items]".
- Objective 6 is "An attractive, viable, safe and well-connected community", focused on community buildings and organisations, public transport, road safety, and accessibility. The proposed cycle centre would contribute to the public transport and accessibility objectives as well as helping to foster connections in the community.
- Objective 2 is "A prosperous town in which the economy generates wealth and provides employment opportunities, so that people can secure quality employment". We hope that seed funding from Stroud Town Council can help us get this project off the ground and create sustainable, quality, employment.

Locally, Net Zero ambitions issued by Gloucestershire County Council, Stroud District Council and the other local District Councils state that "Transport accounts for 34% of CO2 emissions in Gloucestershire, with cars being responsible for 58% of transport-related emissions." Further, "To meet the region's 2030 goal of 80% emissions reduction", there are county-wide aims to "shorten car trips by 7.5%... [and] boost active travel by 300%". These aims will not be achieved without support for projects like our cycle and climate action space.

As we support people to switch car journeys for cycling, we believe this will further benefit residents of Stroud parish both personally in terms of health and wellbeing through active travel, and at a community level in terms of reduced congestion and air pollution, and greater appreciation of the town centre's attributes and connections to the canal and surrounding nature through cycle routes.

We also believe the space will support the town centre offering as a whole and develop a stronger and more sustainable local community – not only encouraging community engagement around sustainability and reduction of CO<sup>2</sup>, but building community more generally through a friendly and freely accessible space with good quality internet connection.

How will your project help to reduce CO<sub>2</sub> emissions? (See quidance notes) A 2021 <u>study by researchers from Imperial College London's</u> Centre for Environmental Policy found:

a year, representing a substantial share of average per capita CO<sub>2</sub> emissions."

Researchers added that "If just 10% of the population were to change travel behaviour, the emissions savings would be around 4% of lifecycle CO<sub>2</sub> emissions from all car travel."

In <u>2019</u>, the <u>National Travel Survey</u> found that 58% of car trips across Great Britain were under 5 miles – a distance that can relatively easily be cycled (such as from Stroud to Stonehouse, Nailsworth or Chalford – though Stroud's topography makes this more difficult for some other routes).

Each person we support who consents would be entered into our Customer Relationship Management (CRM) tool, Upshot. We would then follow up with them at 3 month and 6 month intervals to understand which journeys they have switched from car to bike, and calculate approximate emissions savings.

We would estimate that our work over a year might lead to 50 people switching at least one trip per day from car to cycling, resulting in a reduction of 25 tonnes carbon dioxide equivalent. This would equate to 6-7 kilograms of carbon dioxide saved per pound spent.
