It was noted the WAS Way walk around Stroud leads you through this footpath. The map was produced for the 2007 Stroud Walking Festival. The Assistant Clerk was asked to contact Debbie Hewitt (WAS Way creator) and Andy Read, to ask them to complete and submit Evidence Statement Forms.

It was also agreed to ask ward Cllrs to support the application and investigate with members of the public.

Chas Townley agreed to request a number of Evidence Statement Forms from GCC, to be available at the Council office.

We observe the entrance/exit seems far from visually clear. Any manoeuvres must ensure there is no reversing onto the main road.

S.24/0174/TPO	10 Upfield Close, Paganhill	T1. Yew - Fell to near ground level. T2. Yew - crown reduction by 2.5m. T3. Yew - crown reduction by 2.5m. T4. Yew - crown reduction by 2.5m	Object: We note the absence of a qualified arborist report. These Yew are ancient, slow growing trees, clearly covered by a valid TPO. They also contribute significantly to the street scene. If possible the trees should be registered with https://www.ancient-yew.org/
